

OVERALL SUMMARY OF APPLICABLE SANCTIONS FOR 2018 Q3 QOS MONITORING

In August, an exercise was performed as a follow up to the monitoring exercise carried out in March, 2018 for which Mobile Network Operators were instructed to remedy their non-compliance by 21st August, 2018 or be sanctioned if the default persist. Below provides guidance on the application of sanctions for non-compliance.

Section 6 (under Annex A) of the 3G licence state that "The Authority shall issue directives and sanctions in resolving or failing to meet any Quality of Service Requirement".

Table 1 shows the scheduled sanctions to be issued to respective MNOs:
